Independent auditors, Michael Jensen & Associates has concluded that the financial report presents a true and fair view of the financial position of the PCA as at 31st December 2022 and that there are reasonable grounds to believe that the PCA will be able to pay its debts as and when they become due.

The PCA made a substantial loss in 2022 due to increased expenses across the board, with the largest increase seen in salaries, and the move to the new premises and increased rental costs. Continuing to print and distribute our flagship journal IMPRINT remains one of our largest expenses. While 2022 was an expensive year our new premises in Southbank creates potential to generate new revenue streams and bolster our existing programs through the PCA Gallery, and the new audiences that it attracts. We have made a modest increase to membership fees to support the financial viability of the organisation, while an increased focus on fundraising by Committee and staff is of key importance moving forward.
